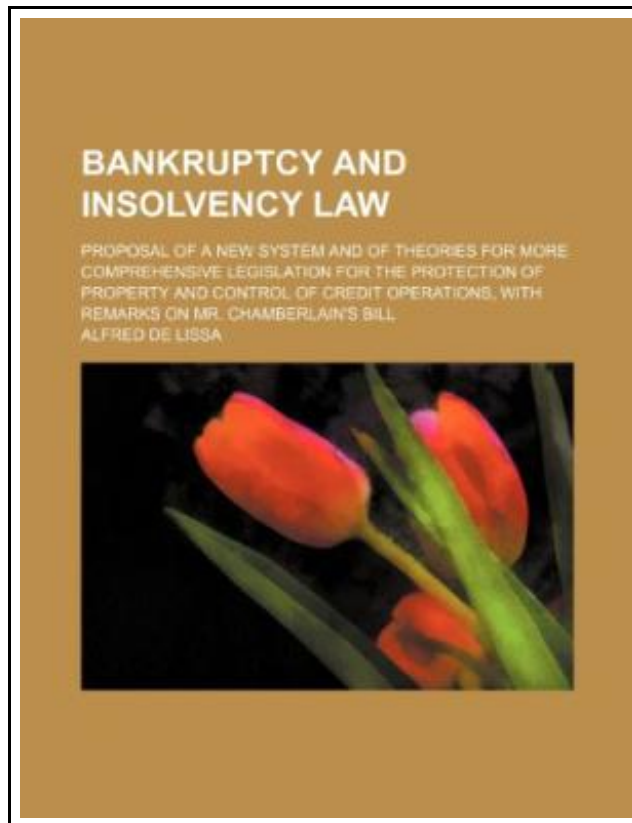

Under the system in general operation, the Bankruptcy Court would be seldom required; possibly only in cases of fraud, or of wilful attempts to evade the law. The system would prevent persons placed in business by others, from obtaining credit upon the faith of the large amount of merchandise in their possession, against which state of things there is no similar protection to that contained in the secret Bills of Sales Act, passed to remedy a similar mischief. There would be nothing to prevent a person being started in business by another consenting to the limit of liability being exceeded; but if the debtor sought to deal with strangers, he would be under the necessity of informing them, before making any proposed purchases, that the limit of liability had been exceeded, and thus giving them an option in the matter, with the concurrence of the principal creditor, if forthcoming. Further, the course which is sometimes adopted of abstracting property from a business, and making it the subject of settlement, would be virtually prevented under improper circumstances, and except under the guarantee that sufficient capital was left to ensure the payment, in due course, both of existing creditors, and of those with whom liability might be immediately afterwards incurred. There are instances of a settlement being made when a trader is actually able to pay current liabilities, and has assets...
